**Newsletter:** Keith Herritt plans on getting next issue out in first half of August and would like submissions by July 26. Jessie Spragge agreed to write a feature on library programs.

**Library Advisory Board:** Margaret will attend LAB meeting at 3 PM on July 20 at Oroville branch. She asked about concerns to bring forward, which led to a discussion of recent remarks made by members of the Butte County Board of Supervisors regarding library funding and what that might mean for the future.

**Librarian's Report:** Jessie Spragge reported that the Summer Reading Programs are going well and she is moving forward with grant applications.

**New Assignments:** Linda Elliott will be our historian; Satsie Veith agreed to write thank-you notes as needed; Merle Burbridge volunteered to take on membership chair and will begin working on "book bucks" ideas.
